-New Hire for Harnett County: Harnett County recently announced Natalie Pusser as the new Director for the County Regional Jetport. Pusser has been an employee at the Harnett Regional Jetport since 2003, and previously served as the Office Manager, FBO Manager, and most recently, the Operations Manager. Her new duties will include directing the County's airport operations, monitoring and implementing safety procedures, serving as the liaison for airport projects and grant funding opportunities, promoting economic development and business expansion at the airport, and ensuring Harnett Regional Jetport adheres to county, state, and federal guidelines. -Fallen Clinton Police Officer gets Tribute: This week, the City of Clinton, in conjunction with Sampson County and the North Carolina Department of Transportation, dedicated a bridge to fallen Clinton Police Officer Donald Ray Tucker, who was killed in the line of duty in 1991. The formerly named Faircloth Freeway Bridge over NC 24 will now be named the Officer Ray Tucker Bridge. The official dedication ceremony was attended by numerous friends and family members of Officer Tucker, who spoke of his lifelong commitment to service. To this day, Officer Tucker is the only Clinton Police Officer to die in the line of duty, and the dedication of the bridge represents the gratitude that the City of Clinton has for Officer Tucker and all the other first responders that have died in the line of duty.
