#### Notable Notes From the Region

- -Roseboro, Erwin Selected for CORE Program: This week, the towns of Roseboro and Erwin were chosen as two of the 34 communities from across the state to take part in the Creating Outdoor Recreation Economies (CORE) Program funded by the NC Department of Commerce. The program aims to optimize outdoor spaces in rural communities around the state and will offer a variety of strategic planning and technical assistance resources. Participants like Roseboro and Erwin will be able to utilize the resources offered through the program to enhance tourist attractions and bolster their local economies. Congratulations to both towns on this great news!
- -Mid-Carolina Workforce Development Board Expansion: The Mid-Carolina Workforce Development Board recently confirmed its expansion into Montgomery and Moore counties. The announcement came earlier this week at an NCWorks Commission meeting in Raleigh. The merger will be officially completed on July 1 of this year. As such, the Mid-Carolina Workforce Development Board will then manage NCWorks Career Center operations in Montgomery and Moore counties, as well as support their community colleges and local businesses.
