Notable Notes From the Region

-Major Investment in Lillington: ILC Dover, a world leader in the design and production of biopharmaceutical, pharmaceutical, and medical devices has completed its construction of an almost 50,000 square foot facility in Lillington. Once the building is up and functioning, ILC Dover is expected to hire between 50-100 employees in Lillington. The new building will increase ILC Dover's capabilities to pre-fill trusted-weight cGMP raw materials for the growing biomanufacturing market, as well as remain competitive in the cell and gene therapy markets. The new facility adds to the large investments that life science companies have made in Harnett County in recent years.

-Upcoming Music Festival in Dunn: This Saturday, the City of Dunn will be hosting the Lucknow Music Festival. The free event will feature nine bands playing on two different stages throughout the day. Festivities go from 1:00-9:00 PM in downtown Dunn's commercial district spanning from U.S. Highway 421 to East Edgerton Street and from U.S. Highway 301 to Railroad Avenue. There will be multiple food vendors and local artisans at the festival, and all downtown parking lots will be open for festival attendee parking.



Special Training for Local Government Professionals

The North Carolina Associations of Regional Councils of Government in collaboration with the UNC School of Government will be holding a one-time, special training on techniques and strategies for retaining local government employees. This session will report local government survey data on recruitment and retention patterns in North Carolina, where local governments are experimenting with a range of tactics to slow employee turnover, attract qualified employees, and build adequate job candidate pools. The session will also discuss the top predictors of turnover intentions from survey data collected from over 5,000 local government employees. Session attendees will learn about recruitment and retention patterns and strategies from the perspective of both managers and employees. The hybrid training will take place on Wednesday, March 22 from 9:00 AM-12:00 PM. Registration cost is \$40, and all who are interested in attending can register through this link.

NC Senior Tar Heel Legislature Members Needed for Sampson and Harnett Counties


