## The Position

The Finance Director position presents an opportunity to join a growing organization as well as assist local government members. The current Finance Director is retiring.

The Finance Director performs complex managerial and leadership work in planning, organizing, and executing the financial activities of the Mid-Carolina Regional Council (MCRC). This position leads the processes for budgeting, receiving, disbursing, and accounting for revenues and expenditures for the organization, as well as leading and managing compliance with federal and state procurement laws and requirements of other funding partners. The work involves leadership and supervision of the budget, purchasing, accounts payable and receivable, investments, and payroll operations. The position also leads, in cooperation with MCRC staff members, the COGs finance technical assistance services to local government members and other regional partners. The employee performs a high level of technical accounting work in the preparation and analysis of financial reports, risk management, annual audit, and other accounting functions.

## The Candidate

We are seeking a credible, creative, and unifying leader who is deeply committed to the success of our organization and is a strategic big-picture thinker. Candidates should bring strengths in both external relations and people-centered leadership with an ability to balance the two. A positive, customer-focused orientation, an ability to deliver high-quality products on time, and an ability to be a strong contributing peer in staff and inter-agency team is required.

Candidate with a combination of education and experience equivalent to graduation from a four-year college or university with a bachelor's in accounting, business administration, finance, public administration, or related field, with considerable experience in governmental finance and CPA Certification.

Master's degree in Business Administration, Accounting or Finance, and CPA Certification with at least 5 to 10 years of local government financial management experience.
